Declaration of Consent and Responsibility

I, the undersigned _____, declare that I want to participate in the sailing course organized by the Waszp Garda Academy (Wagaa) managed by Univela Sailing ssdarl in collaboration with Foiling Hub Lake Garda – Charles kinsley sole proprietorship in Campione del Garda. I am aware that sailing on a Waszp boat requires a certain level of physical and technical preparation, and that the activity may involve physical and safety risks.

1. Participant's Responsibilities:

- I acknowledge that I am in good physical and health condition to participate in the course.
- I undertake to follow all the instructions given by the instructor during the course.
- I am aware that sailing can be physically demanding and that I may find myself in difficult situations.
- I recognize that sailing on foils is technically and physically much more demanding than sailing on no-foil boats.

2. Instructor's Free Will:

- I agree that the instructor has the full right to interrupt or suspend the class at any time if they believe that my safety, health, or that of other participants is at risk upon the occurrence of any of the following conditions:
 - (1) High Wind
 - (2) Excessive waves
 - (3) Insufficient technical level of the student
 - (4) Physical overexertion of the student.

In case of suspension due to the conditions referred to in points (1) or (2) the lesson will be made up later. In the event of suspension due to the conditions referred to in points (3) or (4), the lesson will be made up on Laser Foilsz.

- I acknowledge that the instructor will evaluate the situation based on his experience and judgment, and that his decision will be final.

3. Disclaimer:

- I exempt the instructor, the Waszp Garda Academy (Wagaa), Univela Sailing ssdarl and Foiling Hub Lake Garda – Charles kinsley sole proprietorship, from any liability for any injuries or damages that may occur during the course, unless due to gross negligence or intentional negligence on their part.
- I acknowledge that an accident caused to property or persons is the responsibility of the course participant.

4. Final Declaration:

- I am aware of the risks associated with sailing on a Waszp boat and agree to participate in the course under the conditions described above.
- I acknowledge that this agreement is governed by Italian law and in the event of disputes relating to the activity in question, the Court of Brescia will have jurisdiction
- I have read and understood all the information contained in this form.
- I declare that I have read and received a copy of the information referred to in art. 13 of Legislative Decree no. 196 of 30 June 2003 and I authorize the processing of my personal data and communication to third parties for the sole purposes inherent to the regular performance of the activities of the Waszp Garda Academy (Wagaa), Univela Sailing ssdarl and Foiling Hub Lake Garda – Charles kinsley sole proprietorship.
